



# Tuition & Expenses – College of Health Professions

## For students in the MPH and MSW degree programs:

- An application fee is due at the time the application is submitted.
- Required to pay a nonrefundable background check fee, prior to beginning their applied practice experience or fieldwork coursework. Additional fees may apply.
- Tuition and expenses are itemized and calculated on a per-session basis and are subject to change.

## For students in the MPAS program:

- An application fee is due at the time the application is submitted but is waived for applicants that have applied via CASPA.
- Required to pay a nonrefundable fee for background and fingerprinting check and drug screening. Additional fees may apply.
- Tuition and expenses are calculated for the entire length of the program and are billed in equal payments at the beginning of each session.

A financial statement is available each month and outlines the charges and balances due. Payment of tuition and expenses is the student's obligation.

Application for financial assistance does not negate the student's responsibility to ensure that arrangements for full payment of tuition and expenses are made before the first day of classes. Please refer to [chamberlain.edu/catalog](https://chamberlain.edu/catalog) for the most updated information on tuition and expenses.

Transportation to clerkship, applied practice experience or fieldwork facilities, meals at clerkship, applied practice experience or fieldwork facilities, healthcare insurance and personal expenses, including housing, are not included in the calculation of annual student costs. These expenses will vary according to individual student needs.

Full payment of all tuition and expenses is to be made before the first day of classes, unless other arrangements have been made. The financial obligation for each session must be met in order to register for a subsequent session. Unusual circumstances or a financial crisis should be reported to student services immediately so the University can assist the student in planning or determining if possible alternatives exist.

Chamberlain University reserves the right to change tuition and expenses as necessary. Written notice of planned tuition and expenses changes will be posted in advance.

## Cancellation Policy

The application fee is refundable if applicants cancel their application within ten (10) business days of submitting the application. A student that does not report to the first day of class and wishes to cancel the class, may request a refund of any money paid over and above the application fee and applicable background check and drug screening fee.
